Annotated Provisional Agenda

1. Opening of the meeting.

(a) Purpose of the meeting

The meeting will be opened by UN Environment and WHO as co-secretariats of the Lead Paint Alliance, to be followed by welcome remarks by the USEPA, Chair of the Lead Paint Alliance. The Chair will elaborate on the purpose of the meeting and recent progress and will ask participants to introduce themselves.

2. Organizational matters

(a) Adoption of the provisional agenda

The Lead Paint Alliance Advisory Council will adopt the agenda for the meeting on the basis of the provisional agenda.

3. Review of overall progress in relation to the Lead Paint Alliance Action Plan 2017–2018

(a) Updates from the Secretariat, including status of the GEF project lead in paint component

In August 2018, the Global Environment Facility CEO officially endorsed a SAICM full-sized project with a lead paint component. UN Environment as coordinator of this project will present an update on plans for implementing the project. A supporting document summarising the project will be provided.

The Secretariat will explore the need and feasibility of developing an Action Plan for 2019-2020 given the focus on and the work that will occur as part of the GEF Project and seeks the views of the Advisory Council.

(b) Updates from Advisory Council Members

- (c) Update of Model Law language versions on UN Environment website

Information will be provided about the publication of versions in English, Russian, French and Spanish and plans for other languages.

4. Status of laws (legislation, regulations, standards)

- (a) Survey results

WHO will describe efforts to update the database of countries with legally binding controls on lead paint and will present the latest findings.

- (b) Specific country and regional updates

Country representatives, UN Environment regional coordinators, IPEN and the USEPA will share information about the current status of draft legislation in these countries. A supporting document summarising the outcomes of regional teleconferences will be provided.

5. Lead Paint Alliance communication and outreach

- (a) International Lead Poisoning Prevention Week (ILPPW) 21–27 October 2018

Plans for ILPPW are well advanced and WHO and UN Environment will update the Advisory Council on the availability of campaign materials and the activities that are foreseen.

- (b) Lead Paint Alliance Newsletter

UN Environment will provide information about the next newsletter and its mode of dissemination

- (c) Upcoming events

WHO and UN Environment will briefly describe forthcoming events at which lead paint will be highlighted. Members of the Advisory Council will also be invited to talk about relevant events. A table of upcoming events by the Inter-Organization Programme for the Sound Chemicals Management (IOMC) will be provided.

6. Lead Paint Alliance Advisory Council operations

- (a) Updates on new Partners and Advisory Council members

WHO and UN Environment will report on new partners that have been officially accepted to the Lead Paint Alliance, and also on new members of the Advisory Council.

- (b) Bi-annual meetings – next meeting

The Advisory Council is expected to communicate regularly and meet via teleconference or face-to-face at least twice a year. Proposed timeframes of upcoming meetings are April 2019, and October 2019. Specific dates will be identified after this

teleconference, with input from all participants. One agenda item proposed for the next meeting is the discussion of the draft Lead Paint Alliance Action Plan for 2019-2020 that will be prepared by the secretariat in consultation with the Chair of the Alliance.

7. Any other business

The Advisory Council may wish to consider any other business raised during the meeting.

It is expected that the meeting will last for two hours and conclude at 15:30 Geneva time.
